AMENDMENTS TO LAC COURTE OREILLES TRIBAL COURT CODE GNC.4.11 ANIMAL CONTROL ORDINANCE

- WHEREAS, the Lac Courte Oreilles Band of Lake Superior Chippewa Indians is a federally recognized Indian tribe ("Tribe") organized pursuant to the provisions of the Indian Reorganization Act of 1934, 25 U.S.C. §5101, et seq.; and,
- WHEREAS, the Tribal Governing Board serves as the governing body of Lac Courte Oreilles Band of Lake Superior Chippewa Indians pursuant to Article III, § 1 of the Amended Constitution and Bylaws of the Lac Courte Oreilles Band of Lake Superior Chippewa Indians; and
- WHEREAS, the Tribal Governing Board possesses the inherent sovereign authority to regulate its territory; and
- WHEREAS, pursuant to Article V, Section 1(s) of the Amended Constitution and Bylaws of the Lac Courte Oreilles Band of Lake Superior Chippewa Indians, empowers the Tribal Governing Board to "promulgate and enforce ordinances governing the conduct of members of the Lac Courte Oreilles Band of Lake Superior Chippewa Indians of Wisconsin and providing for the maintenance of law and order and the administration of justice by establishing a tribal court and defining its duties and powers;" and
- **WHEREAS**, the Tribal Governing Board may regulate and impose obligations upon all owners and keepers of animals, in order to protect the safety and welfare of all persons and animals.

NOW THEREFORE BE IT RESOLVED, that the Tribal Governing Board hereby amends Chapter GNC.4. Animal Control Ordinance as follows:
